Qualifications Necessary for an Applicant to be considered for a probationary pipe trades apprenticeship program:

- 1. Must be at least 18 years of age;
- 2. Complete both sides of application and return this form with the following;
 - a. Birth certificate
 - b. Social Security Card
 - c. High School Transcripts or G.E.D. Certificate with official test scores.
 - d. DD214 if you are a US Veteran
- 3. Successfully complete aptitude test;
- 4. Appear for interview when notified;
- 5. Give a negative drug screening provided by the Local 149 JAC.

If you are accepted for a probationary apprenticeship, you will be required to:

- 1. Serve as a probationary apprentice for a period of 1 year (1,700-2,000 hours of on-the-job training);
- 2. Serve a 5-year apprenticeship including the probationary period (8,500-10,000 hours of on-the-job training).
- 3. Report to work on a regular basis;
- 4. Provide transportation to and from work.
- 5. Work in Public Sector jobs without restrictions.
- 6. Work under the direction of a Journeyman on the jobsite and perform job duties satisfactorily.
- 7. Attend related classes regularly and maintain an acceptable average in those classes.
- 8. Purchase test materials for use in related training classes as required.
- 9. Abide by all rules and regulations of the Joint Apprenticeship Training Committee.


