Local Union 250 Dues (\$0.65), Local Union 250 Retiree Christmas Bonus (\$1.00) and United Association Organizing (\$0.10) and Refrigeration Member Fund (\$0.15). For classifications paying (\$2.35) Dues, such dues are comprised of District Council 16 dues check-off of (\$1.10), Refrigeration Member Fund (\$0.15), Local Union 250 Christmas Bonus (\$1.00) and United Association Organizing (\$0.10).

Note: The Employer shall pay to the ARCA/MCA Promotion Fund (\$0.38) per hour worked for all classifications under this Agreement. That amount, which will be included in the "Composite Rate" is to be sent to the Joint Trust Depository.
